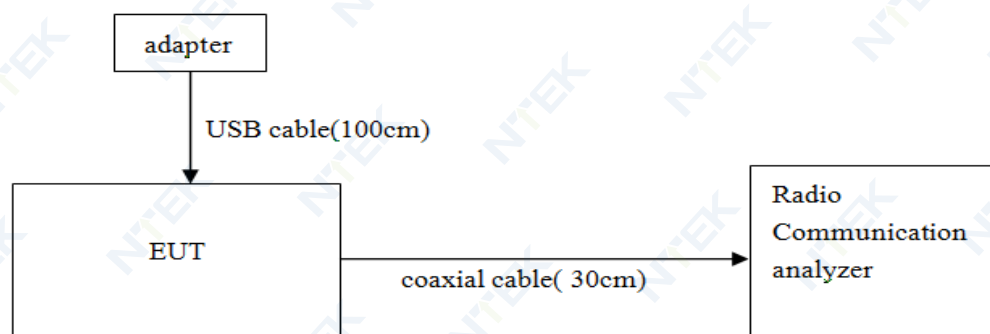

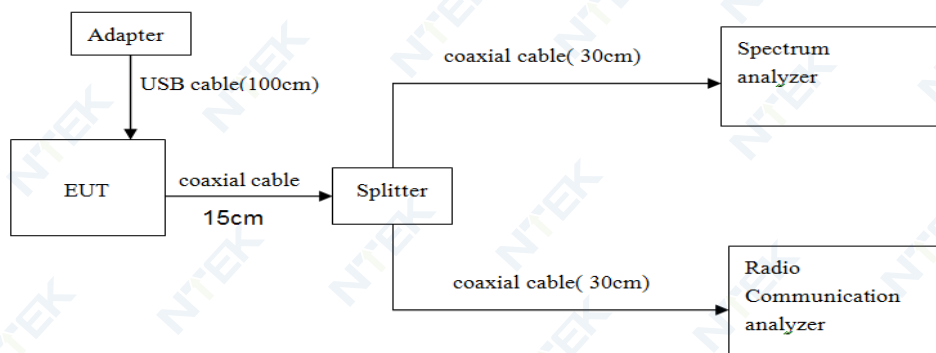




Radiated spurious emissions(Above 1G)

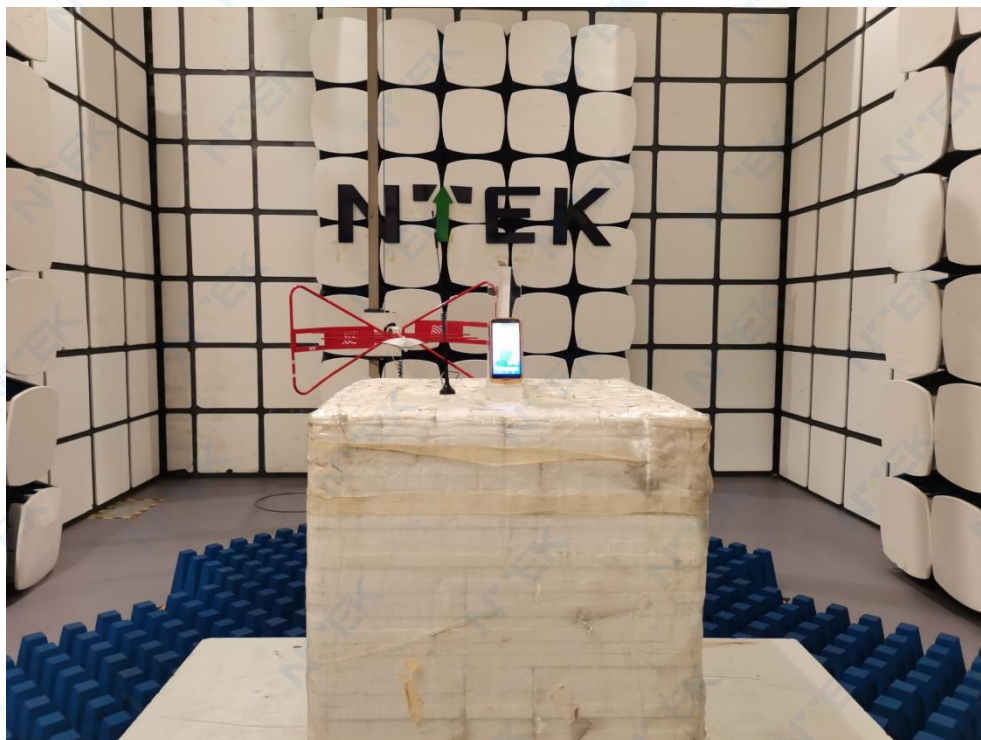
